

My greetings to you and to your family circle in the name of our Lord Jesus Christ.

As to my work;

March 19 Although my feet is not stable, I visited the couple pepito together with his wife who heard on my preaching in hospital, however his wife was not there. Only pepito and his mother heard me.

March 20-21 Because of walking going to pepito's house yesterday my feet hurts, the distance from the road to there house is about a hundred meters, so i just stayed at home and study some beautiful topics sent by brother Ron Halbrook.

March 22 We had our midweek bible study.

March 24 Sunday service. I taught "The true israel is spiritual not physical", brother michael jobber taught the christian family while cynthia, my daughter continues to teach the women brethren after the Sunday service.

March 25 I went to palasan, sta cruz for preaching to my old friends who invited me. They are not in walking distance, instead their house is in a road side only.

March 26 I went to Pepito's family but his wife was still out of town, she is the bread winner of the family so that she must be the one to decide for baptism according to Pepito.

March 27 Once more I went to palasan but their husbands were out of town so that we went to another house for preaching, we visited cynthia's friend in paete unfortunately her husband is always not in their house, so she's still not able to decide for baptism.

March 28 I moved to Manila through the invitation of brother Ely Ebuenga. Although I had a slight fever and a swollen feet before my travel, I did not pay attention to it, i just prayed to our loving father to let me go there for preaching safely. Blessing that the traffic was not heavy, so instead of 5-6 hours, it reduced to almost 3 hours only. During that travel I was about to baptise three(3) precious soul but it ended up baptizing only one soul. They must be converted but a sudden occur. The other two maybe next time in God's will. After baptism we went home to brother Ely's house in Caloocan Vicas. The following day we moved to Cambio, San miguel, Bulacan, I preached the midweek bible study there. They were so glad and asked me to come again. Then we proceed to San Ildelfonso, Bulacan wherein Jay Valdez family and friends are waiting for me. According o brother Ely and Brother Alvin, the said group where turn off to them but I said "Let me to talk him (Jay) on the mobile phone" simply because I am a previous baptist pastor and they are all baptist too. We talked within almost 2 hours and Jay gladly invited me there. So after my preaching Jay was fully convince that there is only one true church. And the way to enter is to hear the precious gospel, believe, repent, confest and baptism. But his mother is very fanatic to baptist church, so due to highly respect to his mother the baptism of Jay and family was posponed maybe next time according to him. I regrets, I did my best, I also discuss the 9 example of conversion in the book of acts. The book of life and the way how our name will be write there, ofcourse by being born again (JOHN 3:1-5; Revelation 20:15 )

Sunday my preaching in Vicas Congregation, my topic I John 5:16 The sin unto death, and the sin which is not unto death. Lots of question but they were all satisfied to my answer. In the afternoon, after lunch Brother Ely decided to bring me in Navotas to Dra. Toreja. She gaved me some medicine and a certain drugs good for 3 months to take, Anti Uric Acid. That the same day we moved to San Pablo for Sunday Service there, then I decided to go home due my acute feet. Brother Ely brought me home then they went back to San Pablo City, 1 hour using his private vehicle.

April 1-3 I obeyed Dra. Toreja's advice to take a rest to avoid swollen feet. I just stayed at home, I didn't like a vacant time that's why I used it on my preaching in social media. I met an Engineer named Phillip Malunay but he became interested to the original church and gospel. I shared him a lot of things regarding to kingdom or the church from the root to the top. Just because he lived in Calauan, Laguna, a town before San Pablo. I encouraged him to visit and hear my preaching live there. Phillip love the truth and hopefully he will be there this coming Sunday, he is a very talented man. Lots of discussion in messenger from different denomination, I defended the truth.

April 4 One of our neighbor talked to me and asked a lot of things about the church up to christ second coming. He was satisfied and last Sunday he must be our visitor but due to urgent family need he said next Sunday.

April 5 Midweek bible study and I also study my topic for the next Sunday.

April 6: went to my prospect in Kalayaan, the Jehovah's witnesses group. We had an argument within 3 hrs. They never denied their inconsistent name of organization which is all outside of New Testament (Perfect Law of Liberty). The ranking organization, their worship day, their way of worship, their way of conversation.

The name Jehovah which is not in Codex Senaiticus in Greek, 4<sup>th</sup> Century yhwh not Jehovah!

830 BCE = The Moabite Stone the name of God is YHWH not Jehovah.

In the book of Jehovah's Witnesses 'Nangangatuwiran mula sa mga kasulatan P.191' the form Jehovah was made by the *New Scholars* (Masorites) year 1400 AD. According to them, yahweh is more correct than Jehovah however *Jehovah* is more popular so they choose it, which not known the ancient Jews nor the Christians. Because the real name of God was not found in Hebrew Text due to a very long time it was not used. It is one of the 10 Commandments, the 3<sup>rd</sup> one. American standard used the word Lord because the name of God is holy and sacred. Js. 2:10-12 the principle of the Old Testament binding in the New Testament also in Heb. 10:26-28. Lots of people will die, that's why some good Hebrews scholar used yhwh instead the real name of God. They said in the James, there's Jehovah as well as in American Standard? I said 'Yes, of course! King James 1611 ; American Standard 1901. 1400 AD when the Masorites put a vowel the Ye Hu Wa H = Ya H We H'.

So they were all silent (the Jehovah's Witnesses). Lots of argument but later on they all became silent! One of them told me that whether they were right or wrong, they will still stay there! April 11 I looked for the new prospect in Kalayaan.

April 12 My support came from Loop, Lufkin TX through bro. Jim arrived so that I went to Sta. Cruz after the withdrawal I bought some prime commodities and in the afternoon, we had our midweek bible study in the afternoon.

April 13 I repaired our fence.

April 14 Sunday Service, my topic was 'What is wrong with Jehovah's Witnesses?' while bro. Jobert topic was 'The contentment in Christ'.

April 15 I'll pay first out PLDT monthly bill in Sta. Cruz, then I will proceed to send my mail for Loop, Lufkin Texas in Paete, Post office, then I'll return to Pepito in Paete for preaching as to what I promised to Pepito that I'll return upon the coming of his wife from her work.

April 16 I'll go to Mindoro for preaching.

By the way, I talked to the children here and their parents to teach them so Cynthia will do this. That's why we need some book and other materials my dear Brethren... Please kindly send us some books and other materials to do this great task...
