As to my works in the past 30 days;

April 16 : I moved to Victoria, Oriental Mindoro through the invitation of Bro. Mario Cay. The same day, I and bro. Mario went to his purposed to share or preach. According to him, it is the 2nd times that this family hear the gospel. They are seven in the family who heard on my preaching. Ariel at the left side is the active among the seven. However, the six was persuaded but Ariel has drink a little wine who was the hindrance for baptism. Unlike before that he was very active and sympathizer of the truth. Satan used the wine, not to obey the 7 souls. Just because the decision was in Ariel at that night.

April 17 : We moved to Alcate, Victoria, my home church where I began. But bro. Bob Agustin and his family were busy in the business, that's why we moved to Pines Camp, Victoria (6 km from Alcate). Bro Basilio gather the members around his house and had an urgent bible study. I taught the importance of worship. The same day, evening, bro. Mario let me preached to the pastora (female pastor) of the Church Redeem. I discussed her the one true Church in the New Testament. She appreciated my preaching.

April 18 : I and bro. Mario went to the new member in the their tricycle Association in Victoria, He and his wife heard on my preaching, 'The kingdom of his dear son' and it's way to enter there in. [Dan 2:44 ; Matt 4:17 ; 4:23 ; 5:3 ; 6:10 ; 6:33 ; 10:7 ] I used only 2 parables of the kingdom [Mk. 9:1 ; Acts 2:1-4 ; Acts 2:36-41,47] A man must be born again, just to enter the into his kingdom at the same time the Church of Christ [Matt 16:18 ; Col 1:13] Christ is the savior of his church; Christ is the deliverer of the Kingdom [I Cor 15:24]. The couple were too happy and appreciated it well. But the next day, for their baptism, unfortunately their friends invited them for picnic. So we went to Aurora just to buy a goat for the gospel meeting in Victoria as a viand. We also went to San Antonio, Victoria just to buy native chickens. Because on April 27, bro. Ron and his company will be coming for the gospel meeting. The same day, we went back to Ariel's family for preaching. But due to Catholic tradition, on holy week, they have wine and drinking.

April 19 : Bro. Mario Cay brought me to his new prospect, member of Dating Daan, lots of reasoning and discussion refute all their human doctrines. But due to gratitude, she said someday... evening, the same day, the pastora and his son together with her daughter-in-law, also the brethren heard on my preaching inside the chapel. Out of 1 ½ hours I discussed the identity of the One True Church, I focused to the Devine Organization of the Church. The plurality of elders, known as the bishops and pastors.

She discovered her reasoning about the female pastor is really not allowed. She said the word pastor is a title, like teacher, lawyer, engineer, doctors, etc. But according to [I Tim 3:1] it's a good work, not title. April 22-25 : I constructed the windows in the room of our daughters as well as their door.

April 26 : Bro. Mario invited me for the gospel meeting there in Victoria. Ron Halbrook and bro. Rudy Gumpad were the lecturers.

April 27 : Three among to our sympathizer before, they decided for baptism. The woman is the younger sister of bro. Ilaw, the previous caretaker of the chapel. While the man is the son of bro. Ilaw and the young fine man is the friend of sister Inday, an old member of the Church of Christ in Alcate, my converted before.

The same day, I received a text that I need to go back home because bro. Narcing was not able to preach due to family problem. I arrived at home about 12 midnight.

April 28 : Sunday Service, I taught the 'Baptism is essential, Baptizer is incidental'. On sermon, bro. Michael Jobert taught the 'Godly life and Wordly life!'

April 29 : I went to Jasaan, Sta. Cruz but most of them are busy harvesting 'palay'.

April 30 : I received a text and call from bro. Ely Ebuenga to go to Manila because of lectureship in Bulacan for the coming of bro. Ron Halbrook, I and bro. Jason Palintang moved to Manila.

May 1 : The 4 of us moved to San Ildefonso, Bulacan to Jay Valdez and his group. Jay and his family were not converted yet due to deep gratitude to his pastor's before. But his younger sister and uncle, the radio commentator were baptized. After baptism, we moved to Vicas, Caloocan, to bro. Ely's congregation, for the lectureship done by bro. Ron. The same day, 1:00 AM when I arrived at home.

May 2 : I took a little rest, in the afternoon, I went to doctor for my foot check-up.

May 3 : Midweek bible study and I taught 'Knowledge shall be increase'.

May 4 : I went to Gym for body exercises, in the afternoon, I went out for evangelism in Kalayaan but the people are very busy for the coming election.

May 5 : Sunday service, I taught 'The Word of God, the mirror of our souls' while bro. Narcing taught 'Necessities for a Christian to grow.'

May 6 : I made visitation to those member who are not attending to our Sunday services.

May 7 : One of my old friend from San Antonio asked my help for a legal matter about the boundary of his land. I go with him in DOJ (Department of Justice) to have a legal decision. Just because barangay advised is none effect. I share him lots of the word of God and now a sympathizer.

May 8 : I and bro. Narcing went to Jasaan, one man who heard us there told us that he'll obey the Gospel upon our return. I also looked for the lots donated by bro. Lino, 20x20 sq meters for the chapel. He also voluntarily gave me 10x20 square meters beside the chapel. All the good lumbers are donated also except expenses and power saw and labor... now the church problem is financial.

May 9 : I and my two daughters, Cynthia and Faith visited and preached to Pepito in Paete, just because he told me upon arrival of his wife, they will obey the gospel, but unfortunately, they are all out in their house, so we went back home because wrong timing for my other sympathizers.

May 10 : I went back to Kalayaan, but due to the incoming election, most of them were busy. Only 2 who heard on my preaching but only for a short moment. In the afternoon, our midweek bible study, I discussed the changing image.

May 11 : Morning, I went to Balian and visited the old member of the Church of Christ there, during my one year ministry there 1999-2001. I saw him in Paete and had a short conversation, he told me to visit them in Balian, they are 4 in the family and I preached them.

May 12 : Sunday Service, My topic was Expository, the Christian duty to the Lord and Christian duty to our fellow Christian. [Matt 25:14-31 ; 25:32-46]

May 13 : Election day, we all went out and vote.

May 14 : I am writing this report morning, and in the afternoon, bro. Narcing and I will go back to Jasaan because of the sympathizer there decided to be baptized this very day. 4 in the afternoon, after a long discussion my prospect was persuaded for baptism. In Lord's will, next year we will be able to start a new chapel there. Bro. Lino Villanueva

donated a lot for the chapel as I mention above. And offered me a lot worth 20,000 for a 200 sq meters. He wanted to give it to me yet I kindly decline, I'm ashamed and don't want to took advantage to his kindness.

May 15 : Today, I am sending this report.

May 16 : Tomorrow, early in the morning I'll go to Subic. Just to see the multicab sale 3 for 100,000. But all papers requirement lawfully for the buyer. All of them are Japan surplus. We are 3 to buy thos 3 units. It is a good service of the church for preaching and also for family. In Lords will, It will be fulfill.

As to the brethren here, they are all fine together with my family.
